

## Leading the Charge on National Public Health Data

### Modernization Reforms

HIA continues to lead the campaign to make critically needed reforms to the government's approach to public health.

### Recently, HIA has:

- Successfully advocated for increased funding for public health data infrastructure, providing billions more for the effort.
- Convened HIA members and key staff at the Centers for Disease Control and Prevention to help shape the public health data modernization initiative.
- Worked with Member and Committee staff on priority legislation including legislation improving the quality of public health data at the state and federal levels.
- Engaged the Biden Administration to implement a modern, usable, public health framework.



## **Advocating for Permanent**

## Telehealth Reforms

As leading telehealth advocates for more than a decade, HIA continues to lead the charge on key policy changes to make telehealth more accessible.

#### **HIA has:**

- Secured regulatory flexibility and extension of telehealth in Medicare for beneficiaries in their homes and in urban and rural areas.
- Helped enact new \$65 billion in funding for broadband investments, which are critical to quality telehealth services.
- Executive Director Joel White testified before the House Ways and Means Committee, Subcommittee on Health on the need to permanently extend telehealth waivers.
- Joel also testified to the FCC on the need to extend the Agency's telehealth programs to ensure continuity of care and access.
- Drafted and helped introduce legislation to expand payment for telehealth services in Medicare, such as at-home COVID tests, while creating incentives for telehealth in employer coverage.
- Helped develop and introduce legislation to ease flexibility for care by eliminating statutory requirements for in-person visits for telemental health, which is now law for 2022.
- Secured expanded MA coverage for audio-only telehealth services.



## Creating a Modern Health Privacy Structure

While Encouraging Interoperability

Inject a needed healthcare-specific perspective in the larger privacy discussion happening at the national and state levels while working to align and revise regulations for a workable interoperability framework.

## HIA is leading a multi-year campaign including:

- Securing introduction of bipartisan legislation, the Health Data Use and Privacy Commission Act (S. 3620), for a Blue-Ribbon Commission to produce actionable recommendations on health data privacy for Congress.
- Working with the Biden Administration to reshape rules to improve data transparency, data sharing and use, and to modernize privacy rules.
- Informing and shaping the rules related to real-time, in-office and pharmacy counter price and benefit transparency and electronic prior authorization.
- Standing up a new Interoperability Working Group to develop policy recommendations and engage allies in next generation interoperability policy to expand data sharing and use.
- Advocating for the use of data-driven solutions, such as artificial intelligence and machine learning in federal programs.






## Driving the Policy Agenda in Congress

### and the Executive Branch

HIA draws on our team's extensive political and policy experience to solve problems and achieve meaningful change – by passing needed legislation and killing bad ideas in Congress and the executive branch. Our team are trusted allies of policymakers and staff.

#### Recent advocacy efforts include:

- Meeting with more than 100 individual offices and committees on Capitol Hill to advance HIA priorities.
- Hosting and participating in 8 virtual events connecting HIA members directly with members of Congress, staff, and high-ranking officials in executive agencies, including CDC and ONC.
- Co-leading an effort of 430 groups urging Congress to make telehealth flexibilities permanent.
- Coordinating 220 advocacy organizations to join with HIA in endorsing the Telemental Health Care Access Act.
- Engaging HIA members in our Biden Administration and Congressional advocacy and providing timely intelligence.
- Drafting policy and securing introduction for the Health Data Use and Privacy Commission Act (S.3620).
- Secured dozens of additional co-sponsors for HIA-endorsed telehealth legislation, bringing the total to 104 new co-sponsors in 2022 alone.
- Convening HIA members and key staff at the Centers for Disease Control and Prevention to help shape the public health data modernization initiative and writing a letter to CDC detailing critical steps for the agency to take in implementing their data modernization work.
- Proactively engaging the White House Coronavirus Response Coordinator stressing the need for secure and verified vaccine records.
- Laying out HIA's priorities and policy goals to HHS Secretary Xavier Becerra.
